USInfoSearch.com is a National Information Service provider. We offer nonpublic and public information to carefully screened and certified entities who are legally qualified to receive this information under the Gramm-Leach-Bliley Act (GLBA), the Drivers Privacy Protection Act (DPPA), or the Fair Credit Reporting Act (FCRA), or other applicable state and federal laws.

This Privacy Policy covers USInfoSearch.com's web site, and USInfoSearch.com's practices for handling personal information provided to USInfoSearch.com over the Internet by the general public using USInfoSearch.com's publicly available web site. USInfoSearch.com will collect, store, and use personally identifiable information only in compliance with applicable laws.

### **Information Collection**

When you browse USInfoSearch.com's publicly accessible web site, you do so anonymously. ## **Cookies and Tracking Technology**

USInfoSearch.com's web site may use the standard technology called a "cookie" to collect information about how you use the web site.
